



Virginia Local Government CRF Spending Survey

Welcome - Please Complete this Survey by August 10 at 5 PM EDT

On May 12, 2020, and July 28, 2020, the Commonwealth's Secretary of Finance, Aubrey Layne, announced that Governor Northam authorized two separate distributions of federal stimulus funding to local governments to address the COVID-19 crisis. The first was distributed to local governments on June 1, 2020. The second distribution is available for each local government pending completion of this survey and submission of a certification form.

These funds are from the Commonwealth's share of federal Coronavirus Relief Fund (CRF) authorized pursuant to the federal Coronavirus Aid, Relief, and Economic Security Act (CARES Act). While the federal CARES Act does not require that states distribute funding to local governments with populations less than 500,000 residents, Governor Northam recognizes that localities are experiencing the same COVID-19 related expenses as the Commonwealth.

In order to better understand the needs of local governments and how these funds will be used to address those needs, the Governor has requested a survey of each local government on its actual and planned use of the CRF funds it has received and will receive in the next distribution. The survey results may be used to advise state and national officials regarding the needs of the Commonwealth in addressing the COVID-19 crisis. Also, please be aware that your submission is a public record and will be subject to the provisions of the Freedom of Information Act.

Please report based on your total allotment noted in your e-mailed survey invitation - not just the first 50% already distributed.

We are requesting that this survey be completed no later than 5:00pm, Monday, August 10, 2020, so that we may provide a report on the use of the CRF by locality to the General Assembly when it convenes for a special session beginning on August 18, 2020. For surveys that are not received by this due date, this report will reflect that the survey results were not received from that locality by the

requested due date. More importantly, the survey must be completed, along with submission of the certification form, in order to receive the second distribution of CRF funds.
